

VALUE OF GOLD IN RELATION TO GOODS IN
THE LATE ROMAN EMPIRE

Though the problem of the value of monetary metals has already been dealt with more than once in historiography, up till now the narrow-monographic papers have prevailed¹. Several important but dispersed pieces of information regarding the principles of the then functioning ore market, and especially the fluctuation of the value of gold and silver, have been taken into consideration only in a few works, in particular, those from the field of Roman mint policy. Moreover, some source documents including data on the subject of the basic level of prices and wages towards the end of the Empire have been used. A little attention has also been paid to the economic and social function of gold in the trade exchange².

Only those problems which were concerned with the dependence of changes in the ratios between monetary metals on the ore resources of the Roman state, were broadly reflected in historiography.

Nearly all the former papers not only limited their considerations to
